Builder members are also billed for assessment fees for permits pulled in Washoe County - \$100 per home and \$20 per multi-family unit. Half of those monies go to the Builders Association Political Action Fund and half of those monies go to the Builder Council Fund, controlled by paying members of the Builders Council.

** Common Ownership—primary company must have full BANN membership for additional company to be enrolled. Documentation required. If primary company membership terminates, additional company will immediately convert to full dues status.)

All membership dues include an annual \$50 processing fee, a \$198 NAHB membership, and \$50 to the Political Action Fund. A portion of dues payments may be deductible by members as an ordinary and necessary business expense. However, \$190 of your dues payment is not deductible for federal tax purposes because it is allocated to lobbying and other non-deductible political expenditures.
